What a 457 VISA means for you and Cogent

So you're interested in moving to Melbourne! Why not? We're proud to be named the planet's most liveable city - full of amazing culture, food, sport and entertainment. Working at Cogent you get to have your cake and eat it, great city, great work and great colleagues. Before we get super excited, have a read of this fact sheet to see if you're a fit for an Aussie working visa.

DO YOU TAKE SUGAR WITH THAT?

WHAT'S A 457 VISA?

Also called a Skilled Visa, the 457 sponsorship will provide you the opportunity to work in Australia for up to 4 years. You will be able to work full-time (up to 40 hours a week) and enjoy the beautiful city of Melbourne!

WHAT'S THE APPLICATION PROCESS?

We look after the nitty gritty but we'll need some of your personal info and important documents to help process the Visa. A comprehensive checklist will be provided to you should you be successful in securing a position with us.

DOES IT LOCK ME IN TO ONE EMPLOYER?

The term of the visa is for 4 years. If you're sponsored by Cogent this means you're locked in with us for this period of time. This may sound scary but no need to fear commitment, we're actually a really great bunch! One of the joys of consulting is that you get to work on multiple projects with different customers.

Over this 4 year term, you'll have no limit on how many times you travel in and out of Australia so you'll get to see your friends and family back home or travel around this side of the world.

DOES THE 457 VISA ALSO COVER MY FAMILY?

Yes! The visa covers you to work for the sponsor (Cogent) and your spouse to work for anyone, so you can both work. It's also really common to apply for permanent residency during this time with a view to becoming a full Aussie citizen. WHAT ARE SALARIES LIKE IN MELBOURNE?

We think they are pretty great. For a mid-level developer you're looking at approximately \$80-120k AUD. If you're more senior, salaries can start from \$120k+. One thing to be aware of in Australia is we help you put away savings for your retirement, otherwise known as superannuation. Superannuation is legislated at 9.5% and Cogent always quotes salaries without the superannuation, so if we say you'll get \$100k then that means \$100k + 9.5% superannuation. If you permanently exit Australia after the 4 year term you're able to withdraw this amount as a lump sum.

Cogent also has a profit share scheme where 50% of any surplus is shared with staff, you'd be participating in this from day one with Cogent. We can explain more about this more through the interview process.
